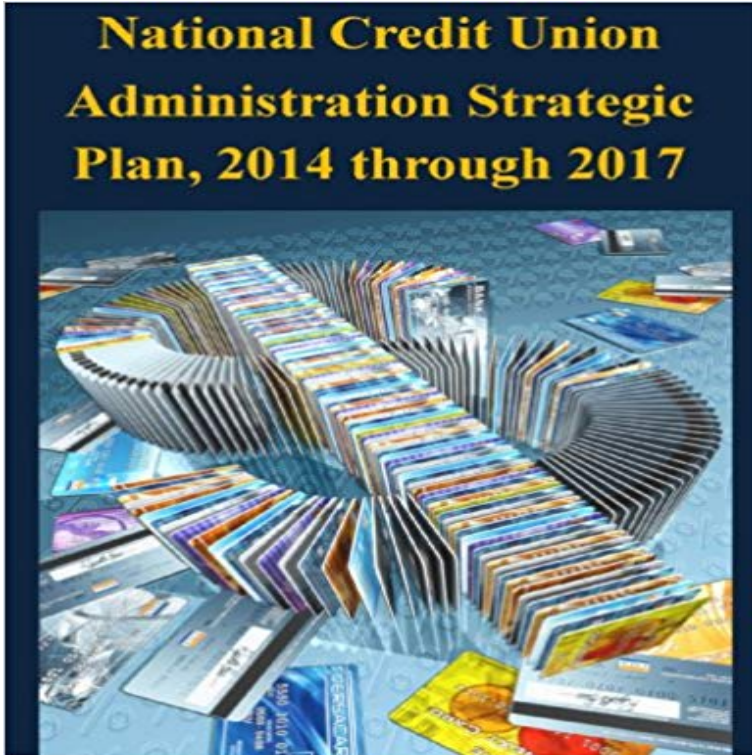


National Credit Union Administration Strategic Plan, 2014 through 2017



The economic environment exerts considerable influence on the credit union industry. As the economy continues to recover, lending opportunities should expand and credit risk should subside. An improving economy will likely be accompanied by rising interest rates, which will affect credit unions income and balance sheets through a variety of channels. In the near term, key fiscal policy risks persist as policymakers continue developing a long-term solution.
