

# Fire Investigations and Arson Scene Evidence: A Guide for Public Safety Personnel



Outlines basic procedures for fire scene documentation and evidence collection. Specific areas discussed include establishing the role of first responders, evaluating the scene, documenting the scene, processing evidence at the scene, and completing the scene investigation.
