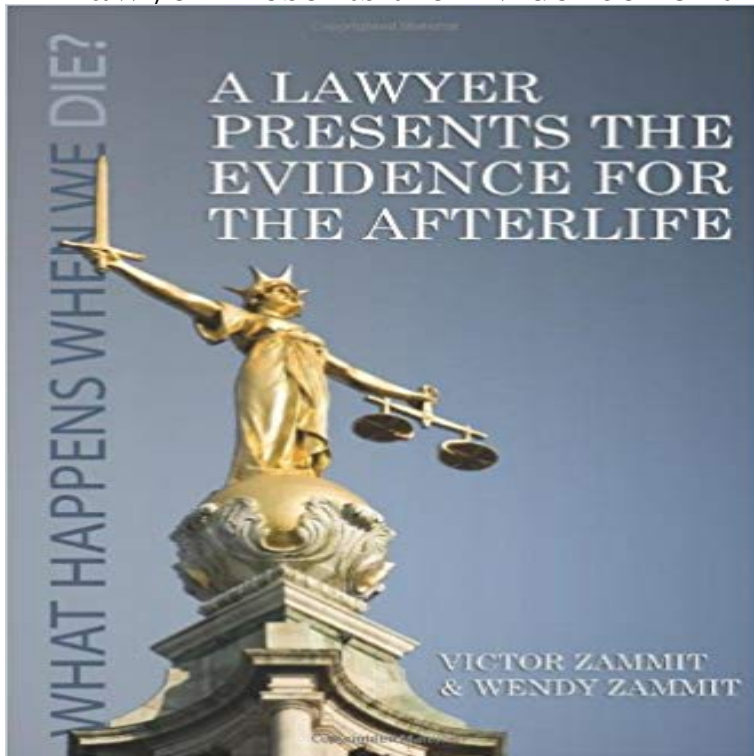


A Lawyer Presents the Evidence for the Afterlife
