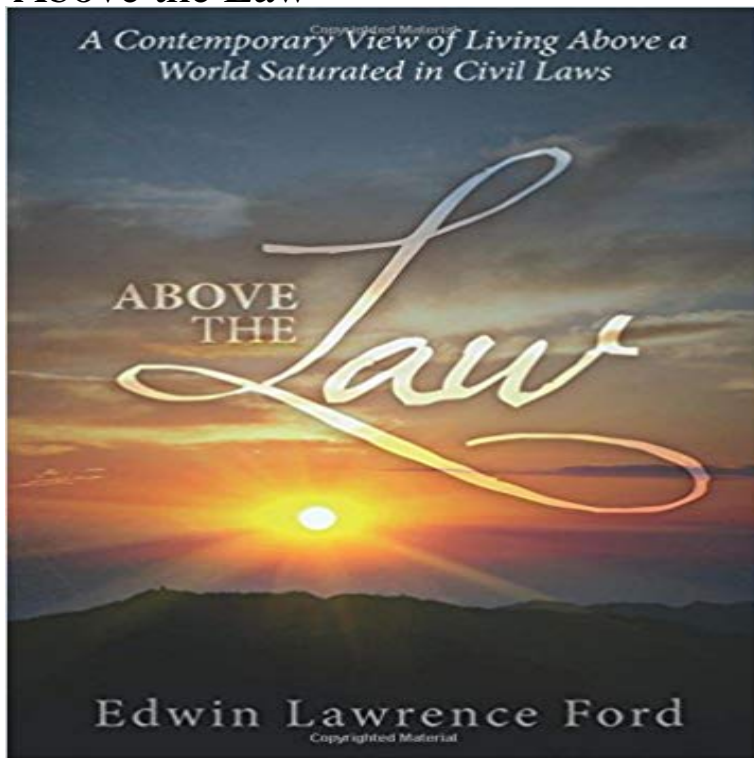


## Above the Law
