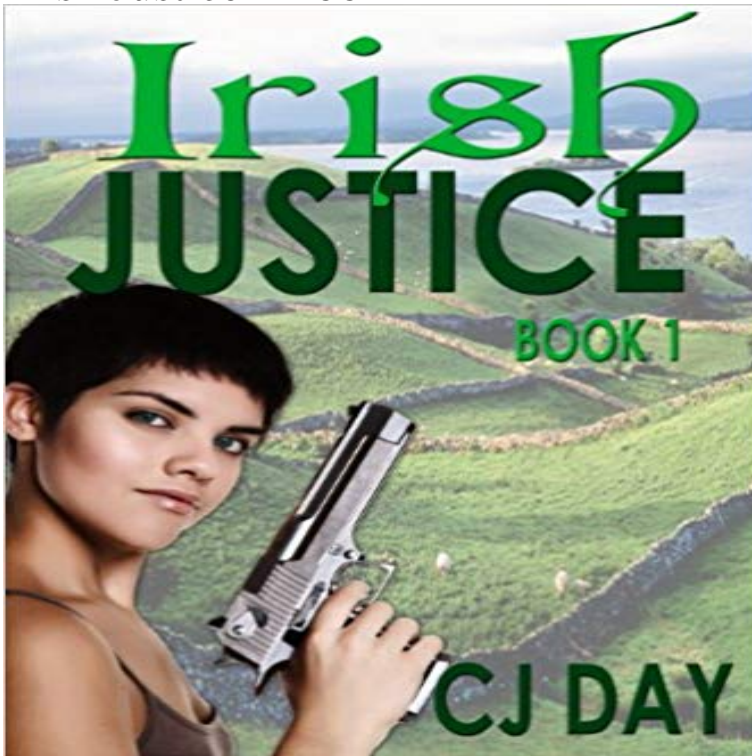


Irish Justice - Book 1
