

The hearing will be in order. I am sorry for the delay this morning, but we had a vote on the floor.Nearly 70 percent of the murders in the U.S. in 1992 were due to guns. Fifteen-thousand-three-hundred-and-sevent y-seven people were killed by gunfire in 1992, 451 in the District of Columbia alone, many of those within just a few blocks of where we are right now. We in the Congress have spent the past several weeks debating the causes of such appalling statistics, trying to fashion measures which would help reduce them. We have agreed to add money to put more police on the street. We have debated tougher sentences, more Federal crimes, additional housing or prisons for prisoners, and many other ideas.As we consider these measures, the entire Nation is grappling with the grave problem of an increasing violence in society, and our constituencies have told us that crime is their biggest single worry today. It is obvious that the easy availability of weapons to those with criminal motive is a factor in the increase of violent crime. Keeping sophisticated weapons out of the hands of criminals should be a top priority. That means, among other things, that the largest holder of sophisticated weapons, the military, must carry out its special responsibility to keep such weapons and their spare parts secure. GAO has found that stolen military weapons parts are readily available at gun shows across the country.
