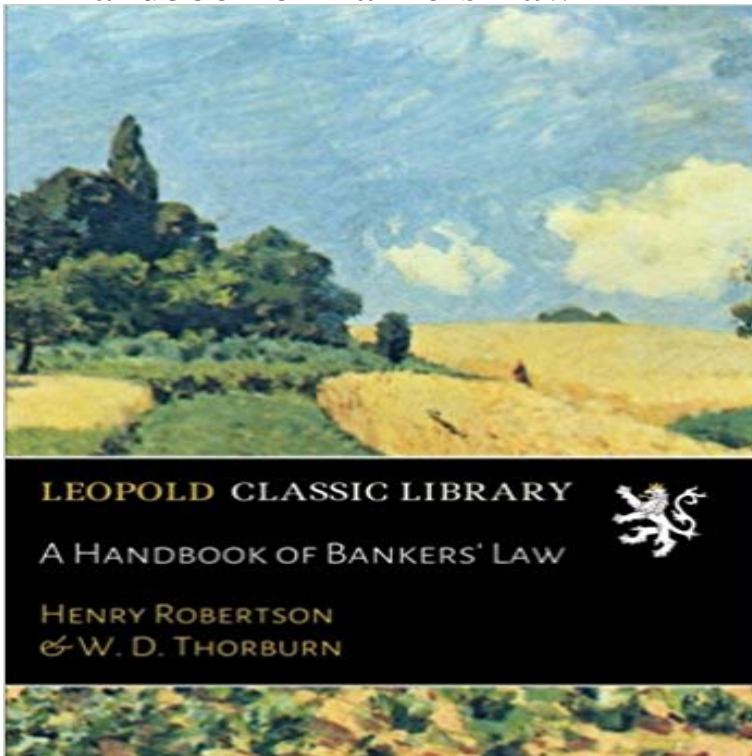


A Handbook of Bankers Law
