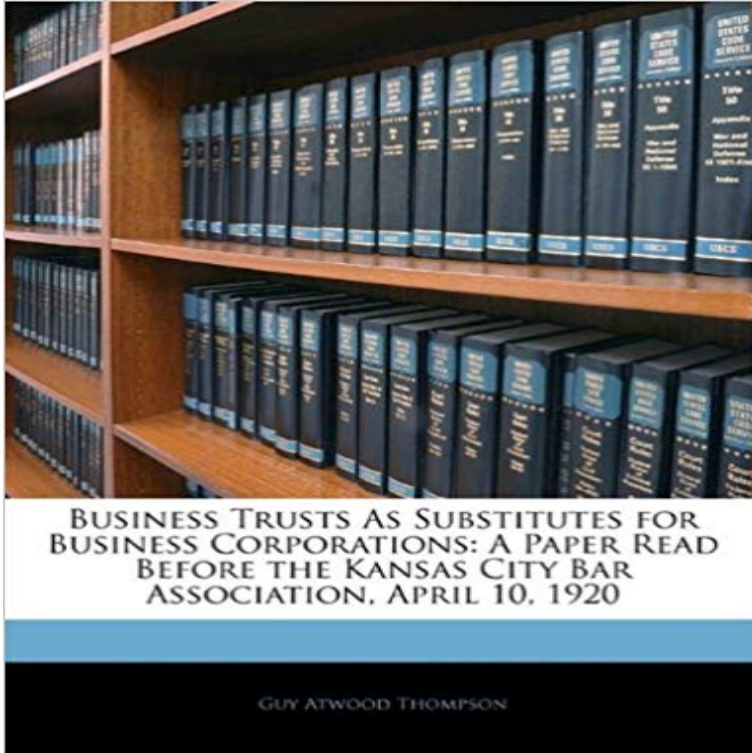


# Business Trusts As Substitutes for Business Corporations: A Paper Read Before the Kansas City Bar Association, April 10, 1920
