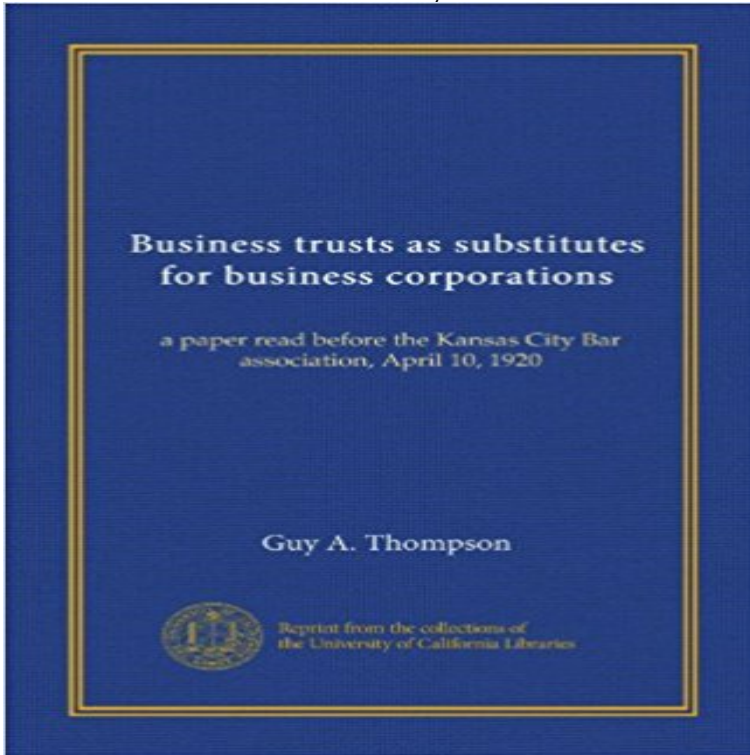


Business trusts as substitutes for business corporations: a paper read before the Kansas City Bar association, April 10, 1920
