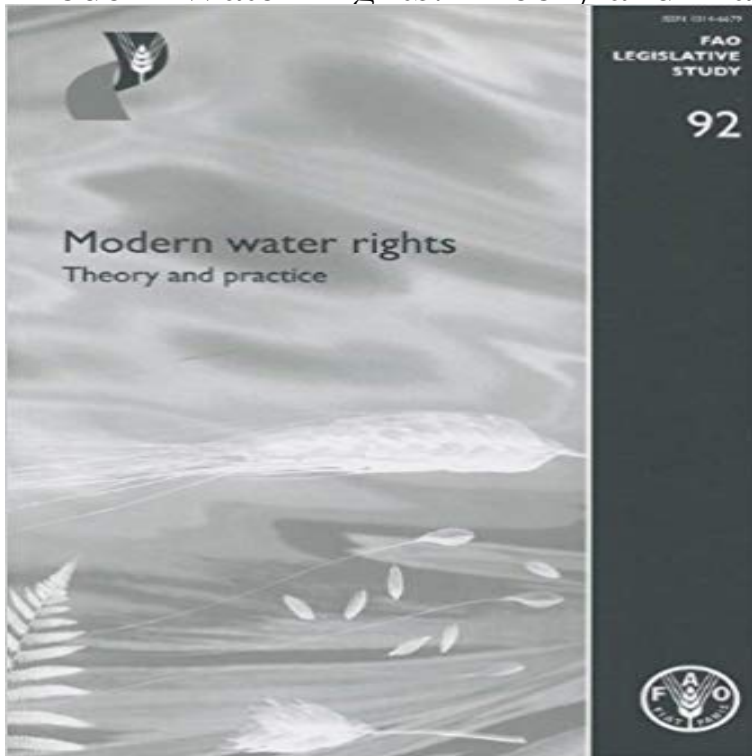


## Modern Water Rights: Theory and Practice (FAO Legislative Studies)
