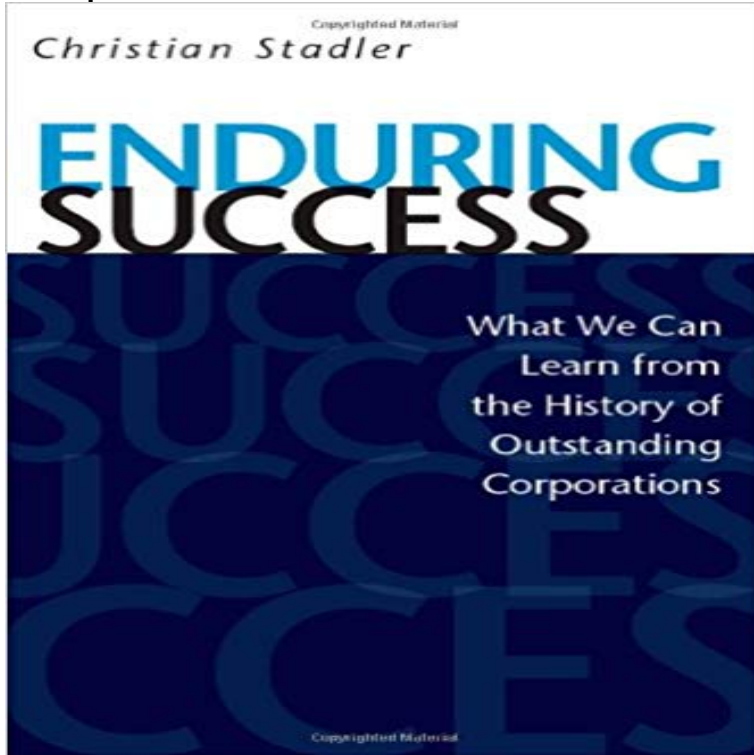


# Enduring Success: What We Can Learn from the History of Outstanding Corporations
