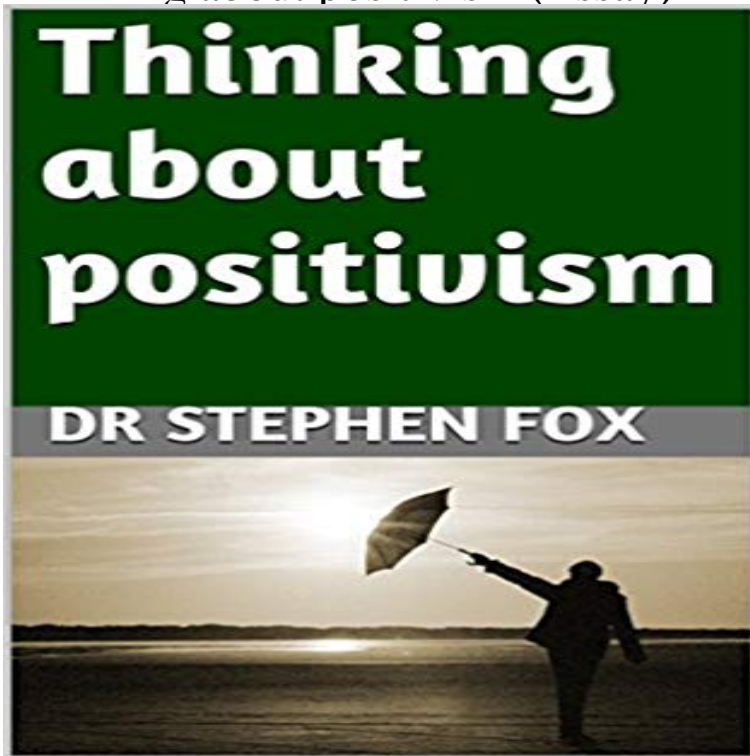


Thinking about positivism (Essay)
