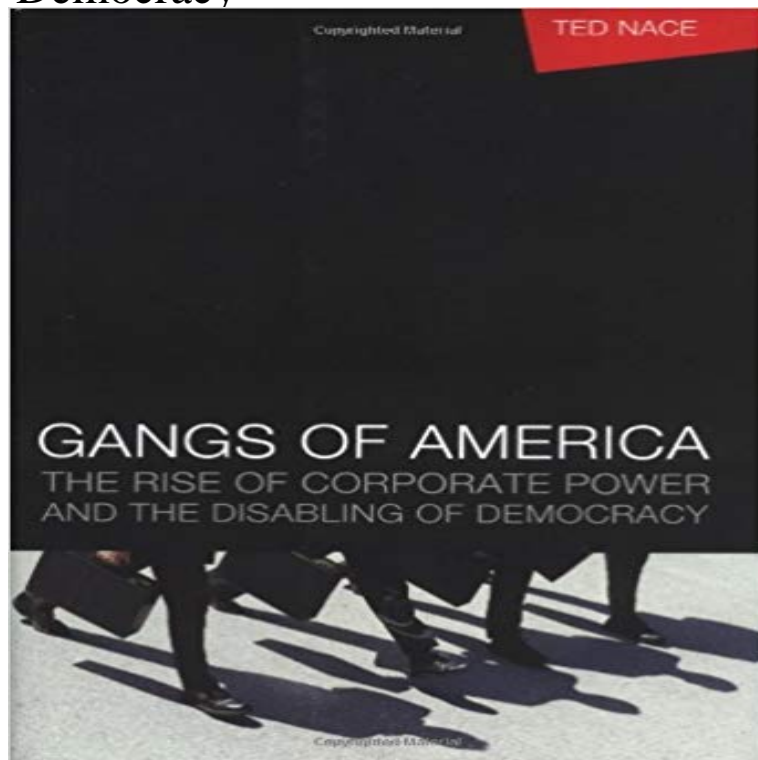


# Gangs of America: The Rise of Corporate Power and the Disabling of Democracy
