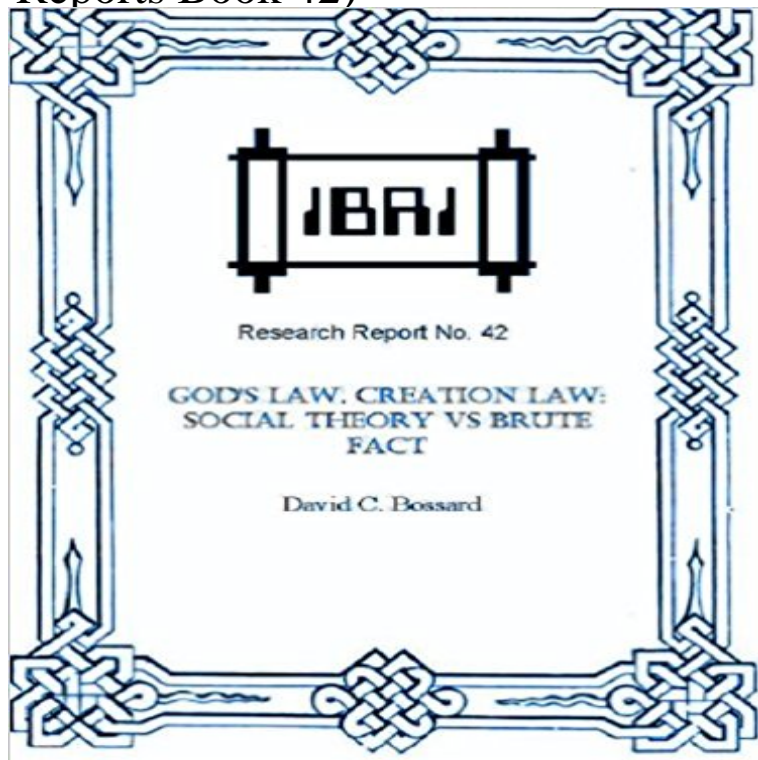


Gods Law, Creation Law: Social Theory vs Brute Fact (IBRI Research Reports Book 42)

It is argued that these creation laws form a valid basis for Christian involvement in secular institutions that is consistent with the spirit of the constitutional separation of church and state.
