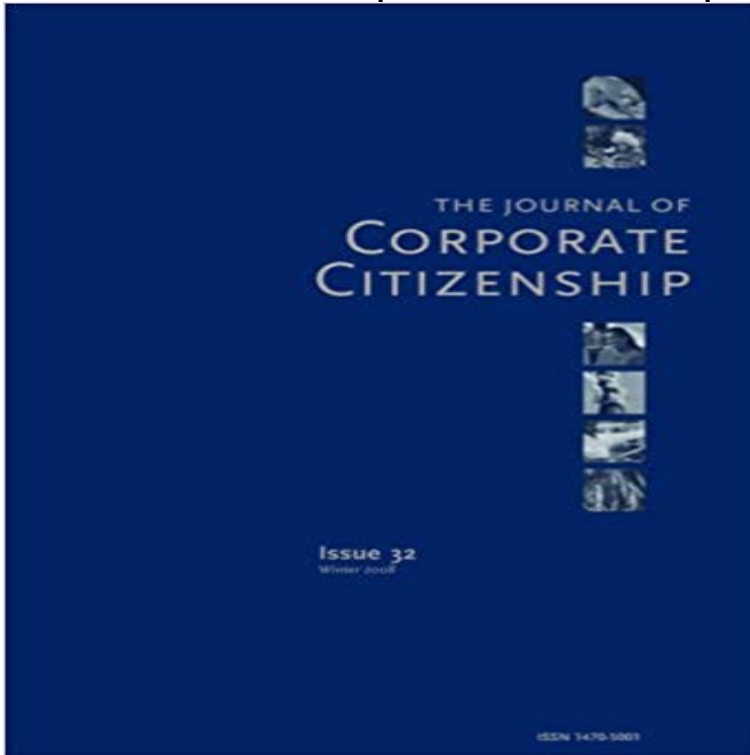


# Responsible Investment in Emerging Markets: A Special Theme Issue of The Journal of Corporate Citizenship
