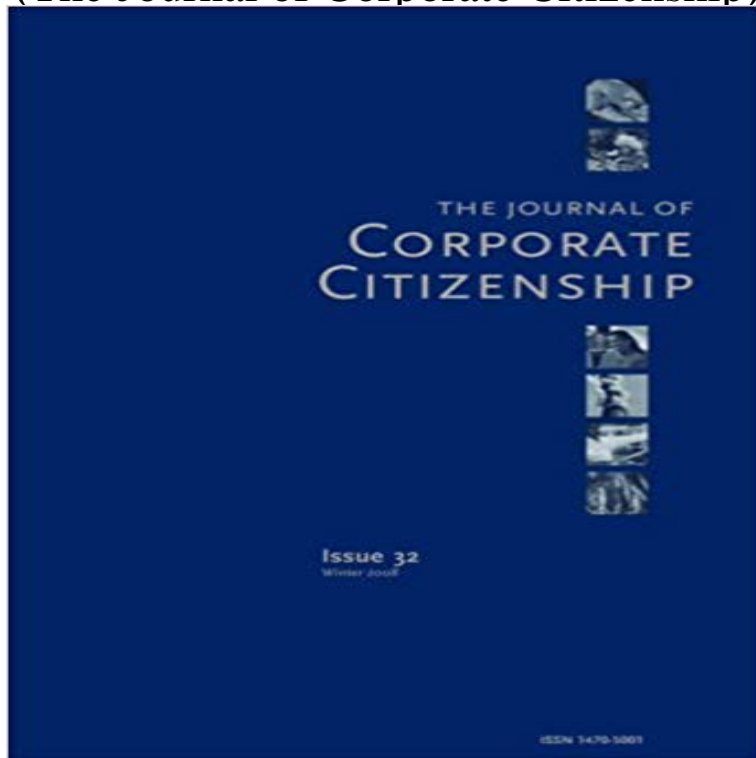


## Corporate Citizenship in Latin America: New Challenges for Business (The Journal of Corporate Citizenship)
