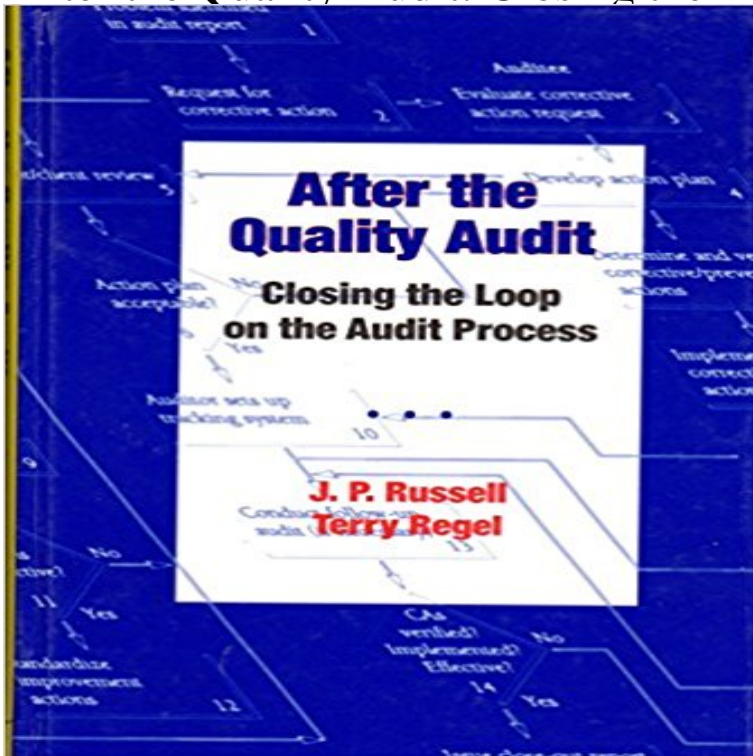


After the Quality Audit: Closing the Loop on the Audit Process
