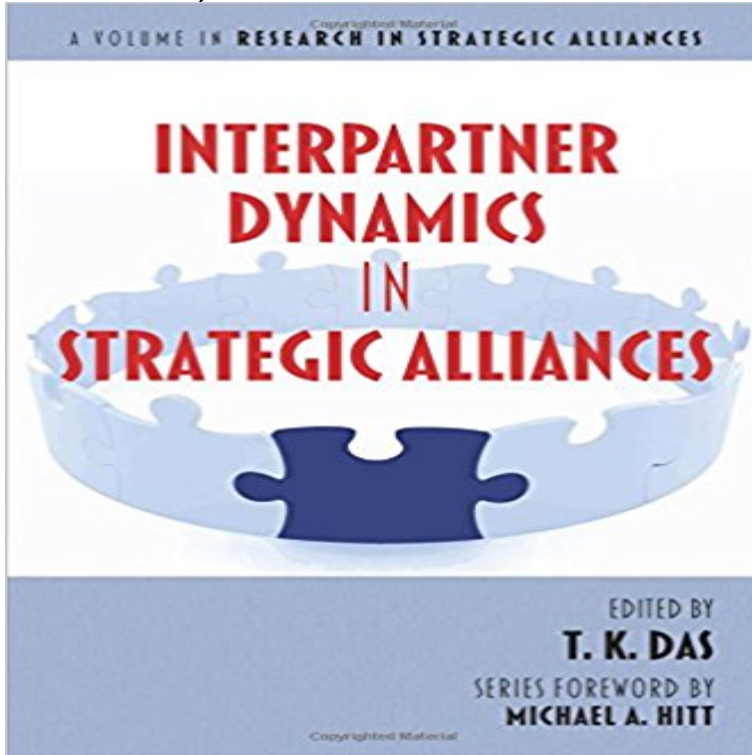


Interpartner Dynamics in Strategic Alliances (Research in Strategic Alliances)
