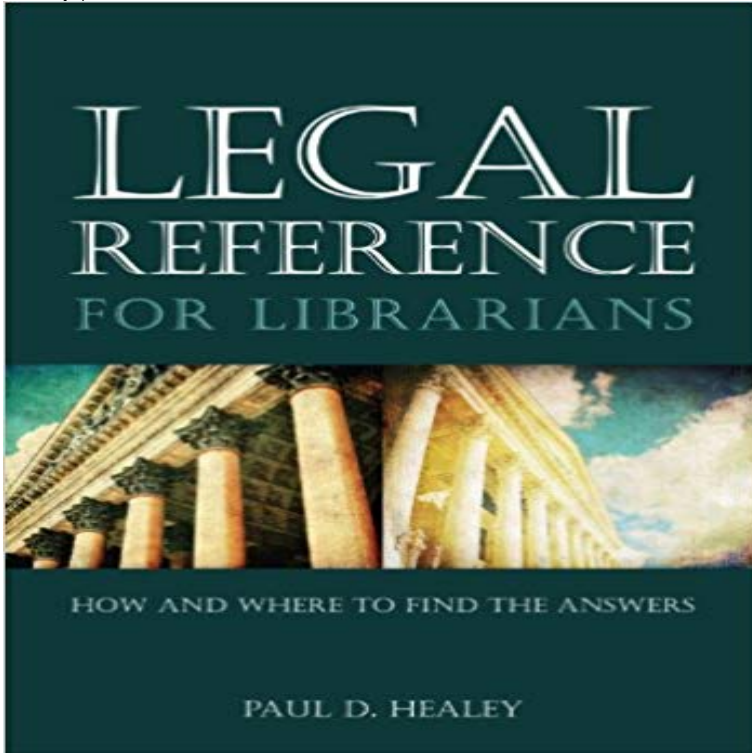


# Legal Reference for Librarians: How and Where to Find the Answers
