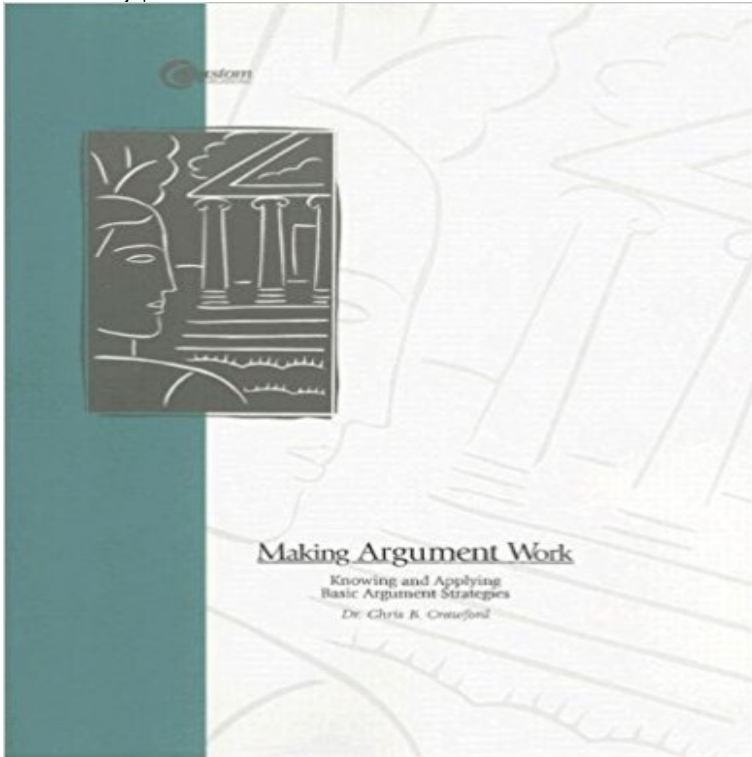


# Making Argument Work: Knowing and Applying Basic Argument Strategies
