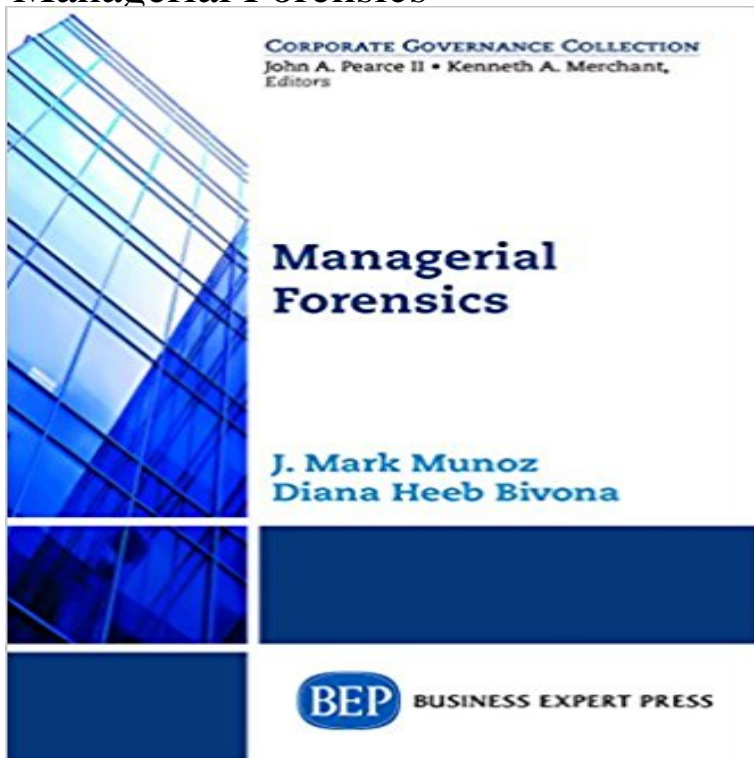


# Managerial Forensics
