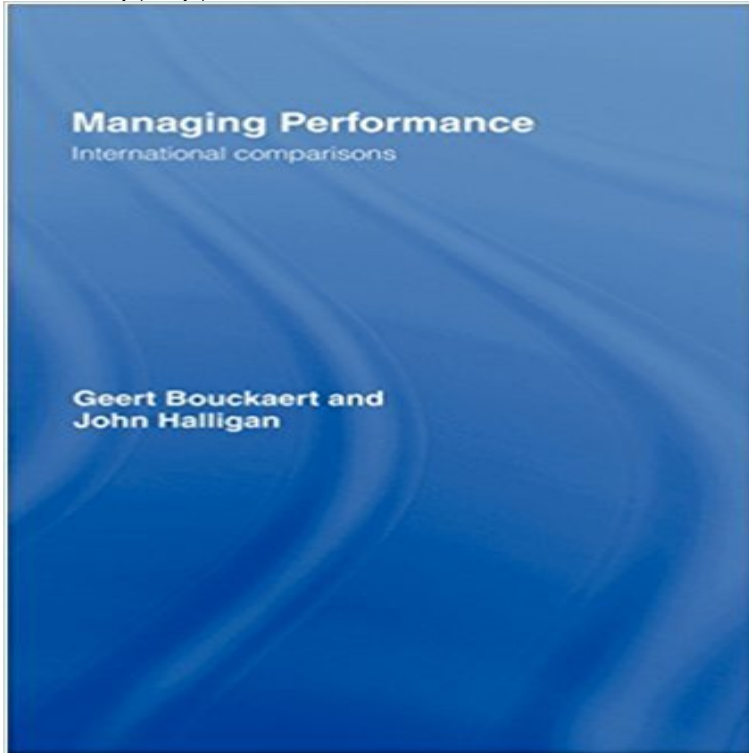


# Managing Performance: International Comparisons



In recent years, concerns over the effectiveness of public administration have encouraged the widespread measurement and management of performance.
