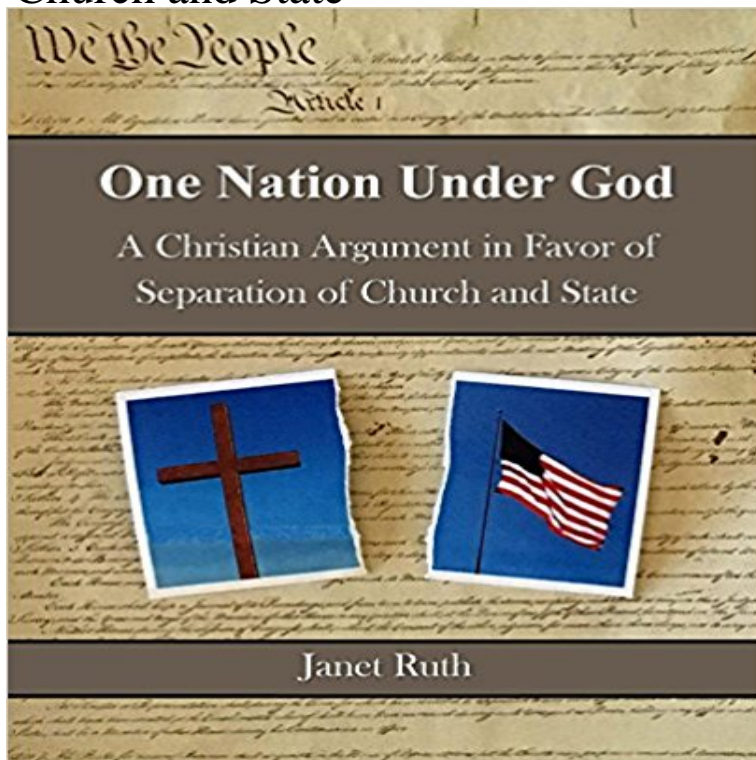


# One Nation Under God: A Christian Argument in Favor of Separation of Church and State
