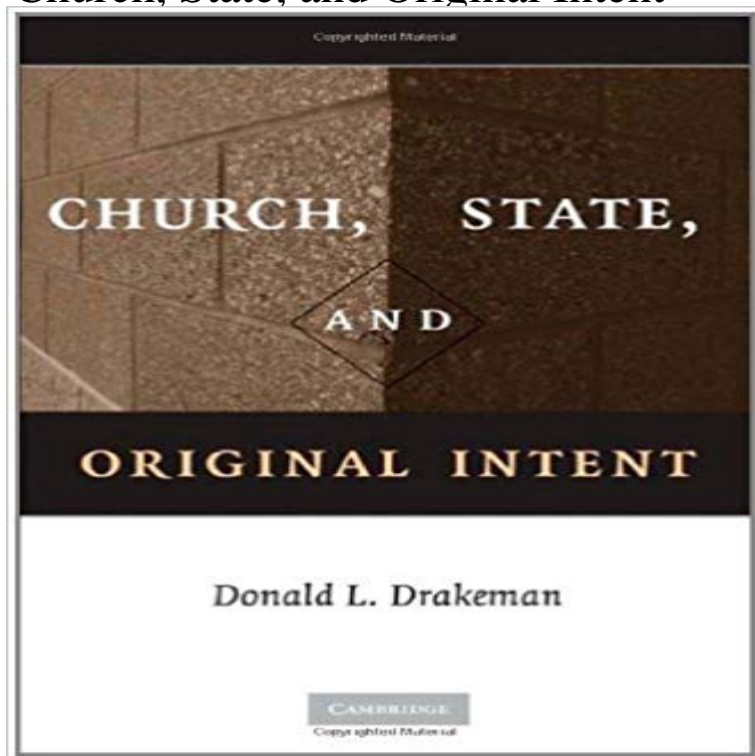


## Church, State, and Original Intent
