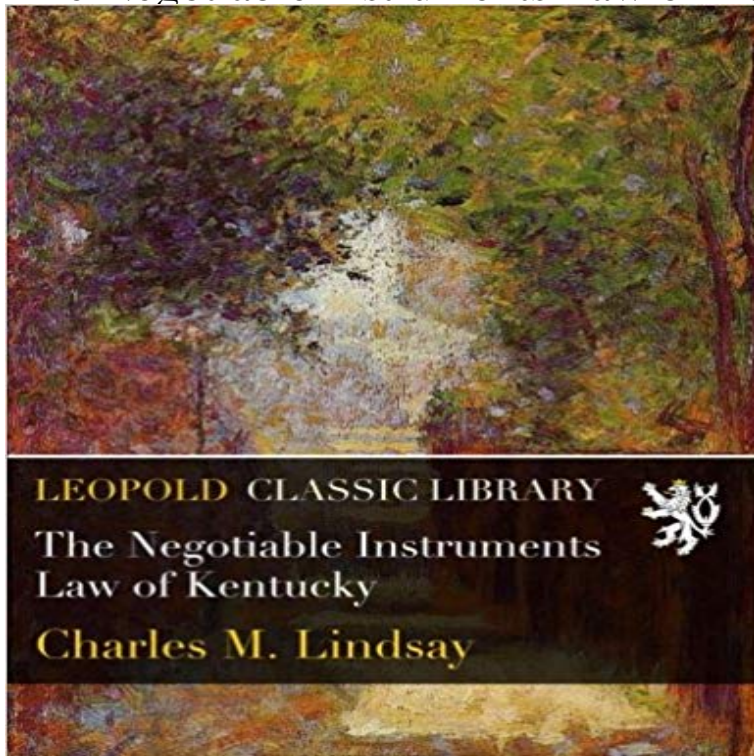


## The Negotiable Instruments Law of Kentucky
