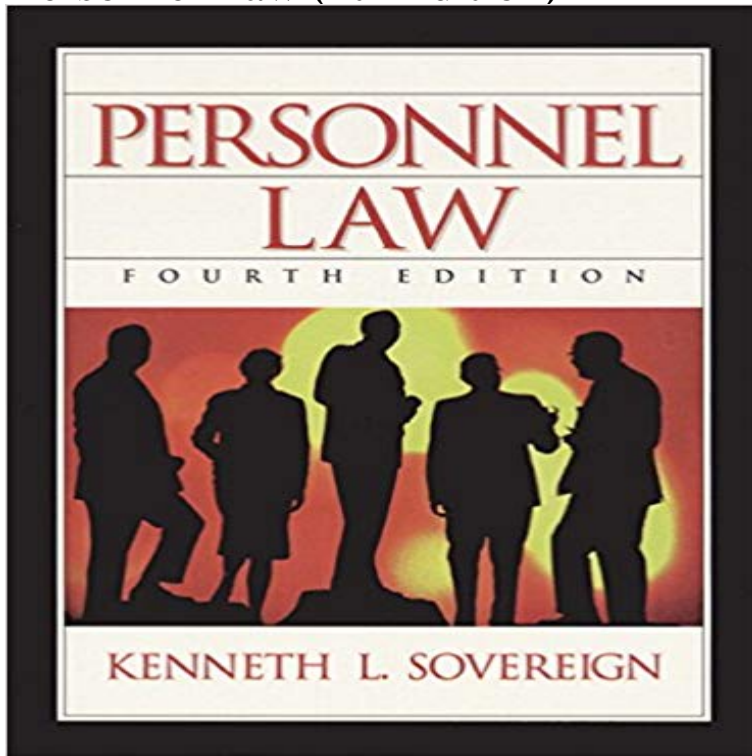


## Personnel Law (4th Edition)
