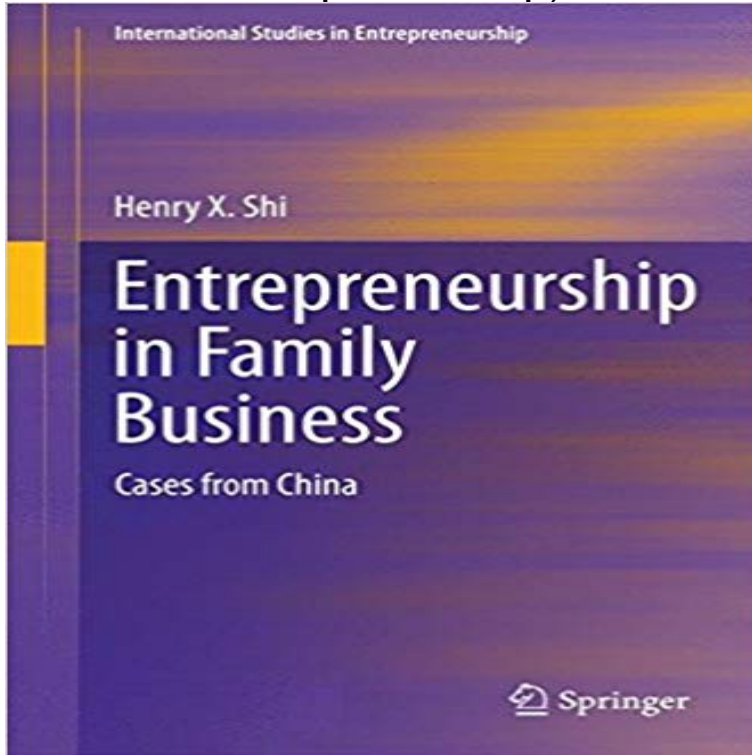


Entrepreneurship in Family Business: Cases from China (International Studies in Entrepreneurship)
