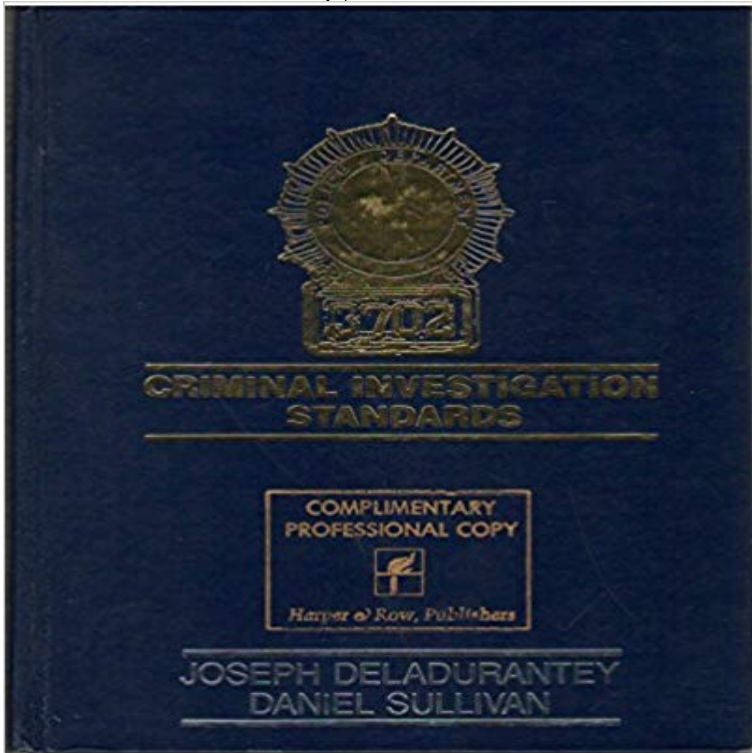


Criminal Investigation Standards
