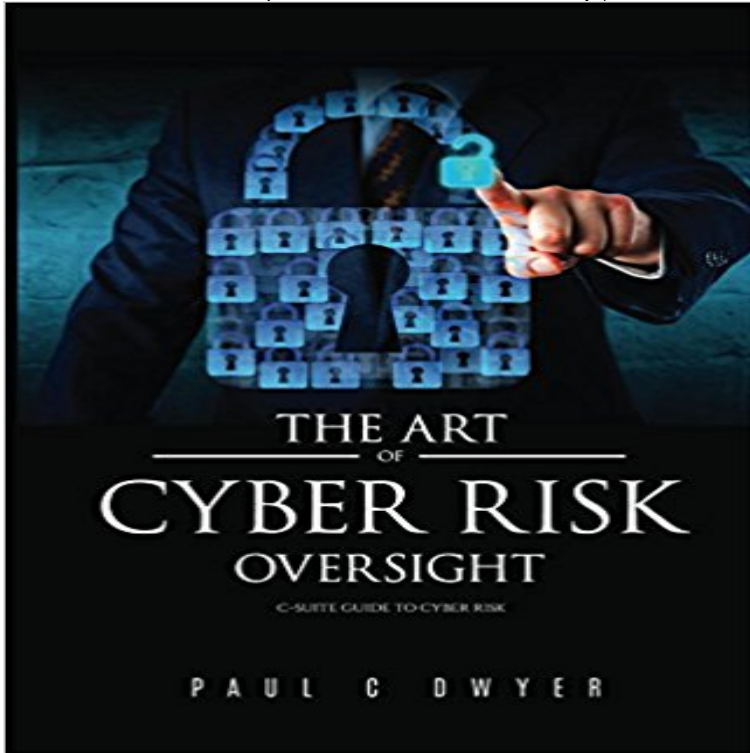


The Art of Cyber Risk Oversight: C-Suite Guide To Cyber Risk
