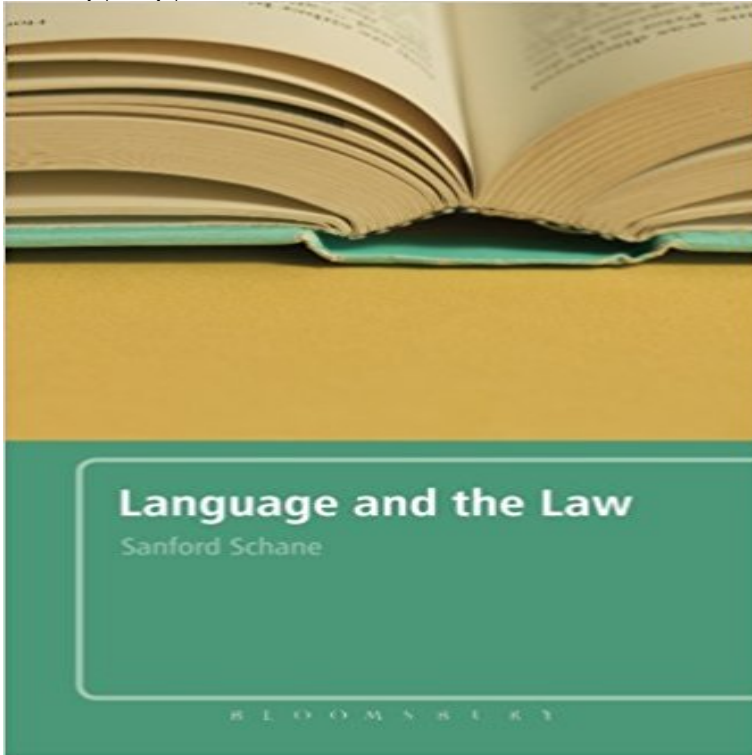


## Language and the Law: With a Foreword by Roger W. Shuy
