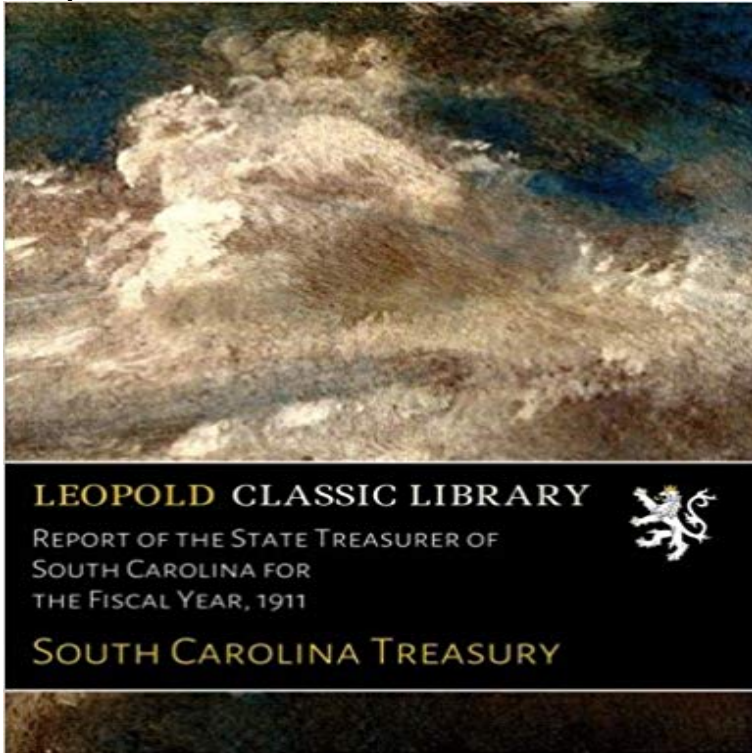


# Report of the State Treasurer of South Carolina for the Fiscal Year, 1911
