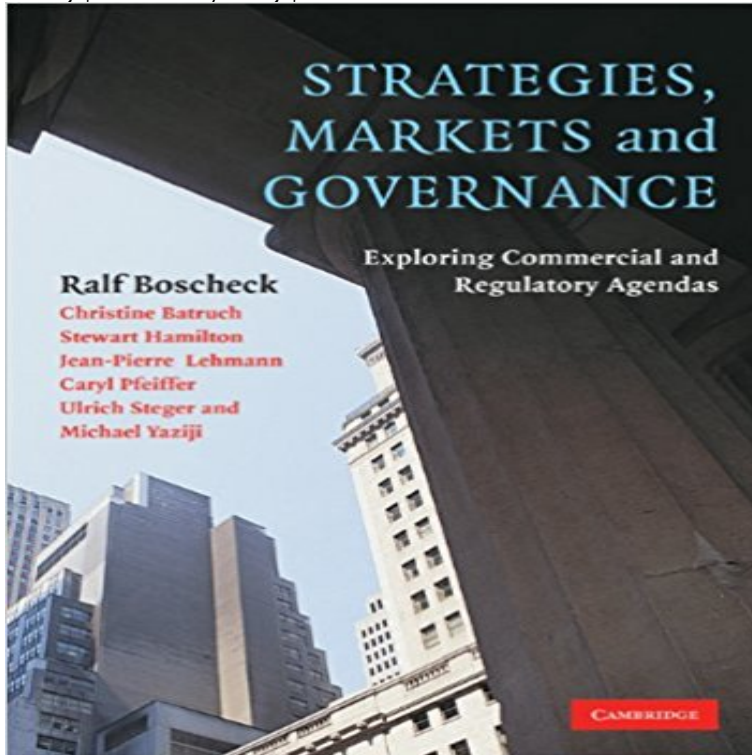


# Strategies, Markets and Governance: Exploring Commercial and Regulatory Agendas
