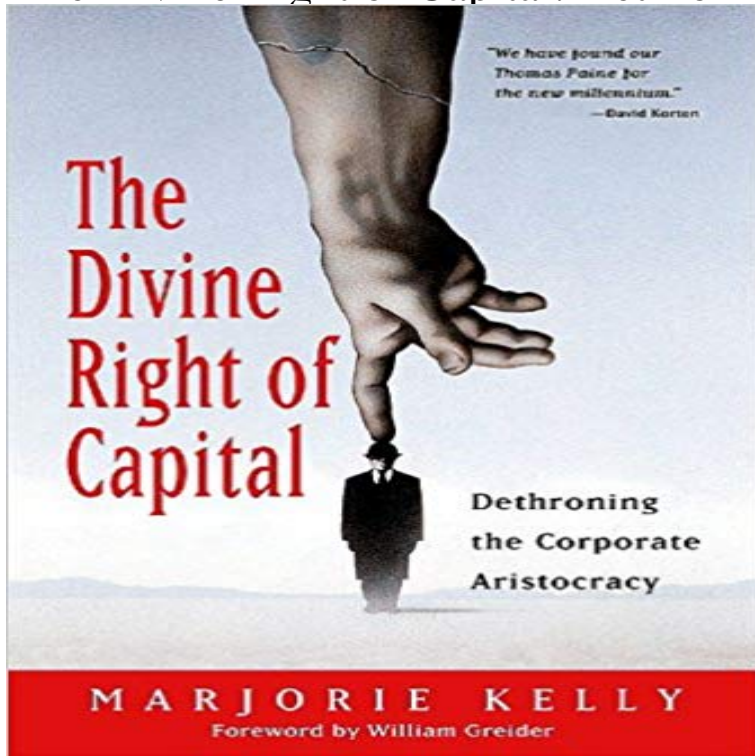


# The Divine Right of Capital: Dethroning the Corporate Aristocracy
