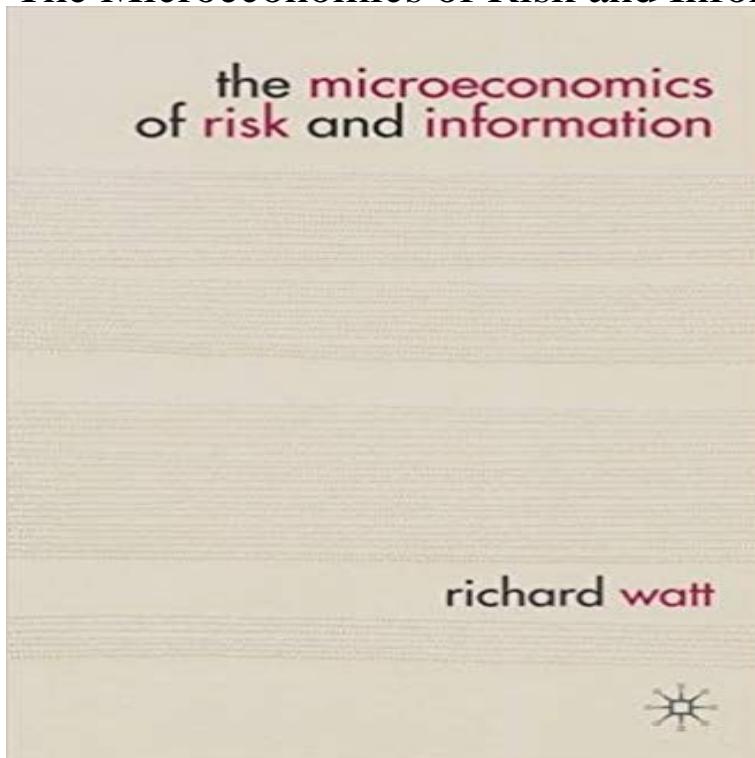


The Microeconomics of Risk and Information
