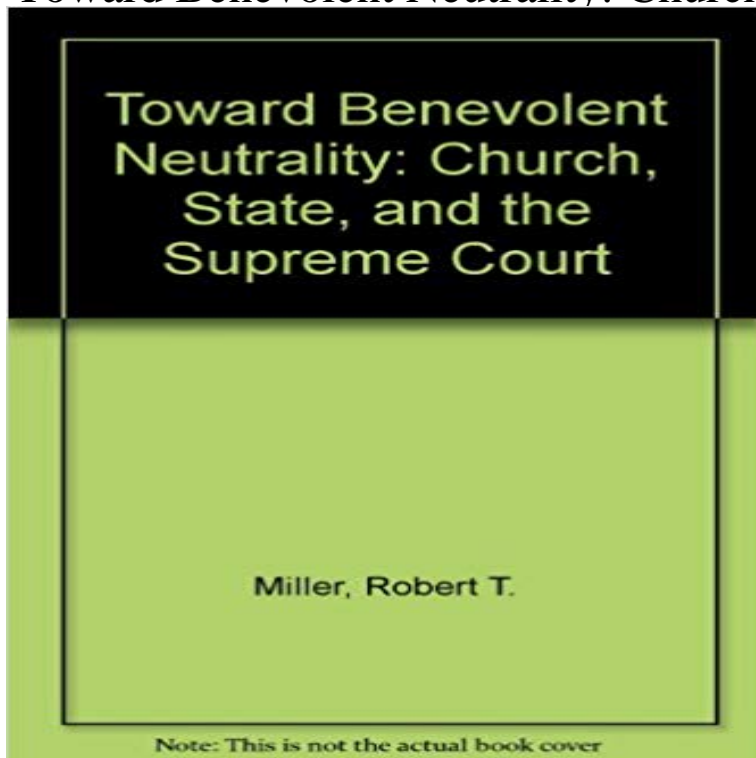


# Toward Benevolent Neutrality: Church, State, and the Supreme Court
