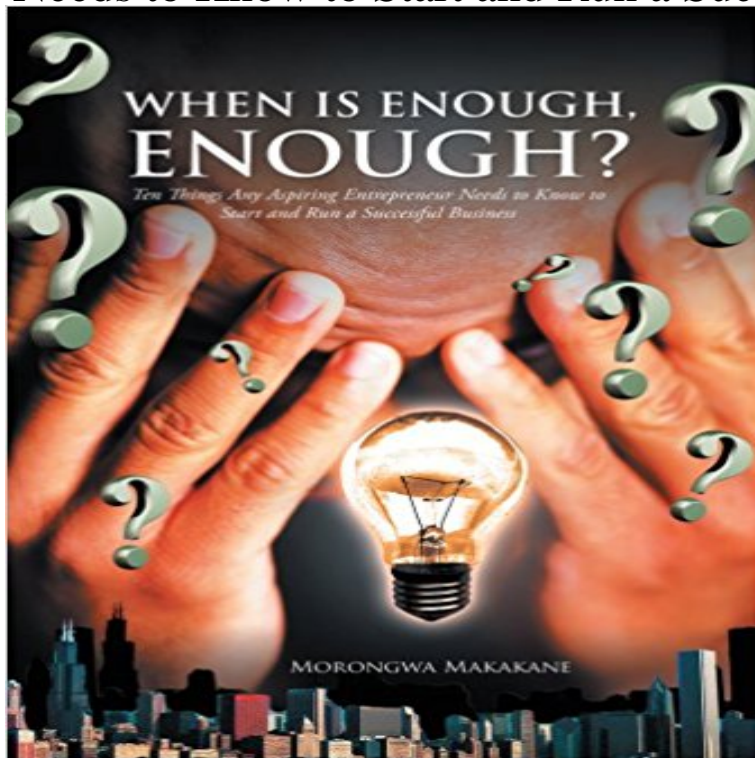


## When is Enough, Enough?: Ten Things Any Aspiring Entrepreneur Needs to Know to Start and Run a Successful Business
